Reviewed minutes of 2007 Annual Meeting. Anne Knight made motion to accept minutes as presented – Second by Marty – minutes approved.

Will - Treasurer's report

40 dues paying members

\$1350 – balance forward. Expenses to date are \$1150

We will probably spend the remainder for water sampling before the July annual meeting

Fiscal year ends June 30th

\$1250 is allocated to Mary Perry Conservation fund, leaving an operating operating balance of \$200.

<u>Membership</u> – Update to membership database by Lisa. Nancy V will "migrate" the entire watershed database from Excel to Word document in order to make a report of members in a "friendlier" format.

Summer/winter address should be designated. Invalid addresses will be corrected when possible, or person's residence validated at Town Offices. Otherwise person should be removed from the database.

Water Quality - Galen

1 tributary sampling taken so far. Chloride testing OK but need to continue to include manage/maintain the shoreline and overall health of pond re. Chris's presoentation at last year's Annual Meeting.

Cynobacteria (neurotoxin) lacted with tiny blooms last year – aided by phosphorus – high temps – long drought followed by heavy rainfall. We must be on the lookout for it...not good to come in contact with it.

We should list the "green" do's and don'ts on our WOPW website. We can post the handouts from DES on our website and have other DES information accessible via links on the website. Place the list under "water quality" and the list of do's and don'ts. (bullet points) should be right there.

NH volunteer lake assessment program for White Oak Pond – biennial report 2007 from DES – sent to Nancy V.

Suggestion: send a postcard of do's and don'ts to all people in the watershed. Also send notice about Mary Perry Conservation fund and annual meeting.

Janet C suggested that a copy of the biennial report be sent to SLA so they can keep them on file. Nancy will send reports from 2005 on to SLA via Janet.

Summary of WQ will be ready for annual meeting

<u>Dam update</u>: Janet met with Board of Selectman about dam. The selectman would like dam maintenance processes in place. Barry Eastman's health is of concern. The top board was removed to prevent road flooding and replaced too early this spring whereby it affected the fish trying to spawn downstream. There was too little water in the stream. We are looking for a back up person for Barry. The selectman have money set aside for the management of the dam. Need to replace rotted boards and rusing mechanism. Having someone from SLA or the Fire Department to manage the dam is a possibility.

After ice out this past spring the lake went down a foot/16" very quickly...the precipitous drop is unhealth. We don't know who opened it or when they opened it.

Janet mentioned the Holderness Selectman meeting to be held at the Town Hall on Monday, June 9th. The dam is on the agenda. Walter Johnson, our town administrator would like a representative from WOPWA at the meeting. No one is able to attend so Janet will contact Peter Webster post-meeting for updates.

Issues are: Date trigger – water level trigger – don't want spring run-off on road – there is a date for draw down in the fall...Peter Furmanik is not the guy...

Suggestion: Investigate getting a device that monitors the level of pond – GPS uses it – someone could look at what's happening and put board in...Janet C called Peter Webster this morning and he gave her this update. Janet will get in touch with Chris Devine/Peter after meeting to see what they decided.

Lake access signage - Ted/Bob

Ted thanked Kevin and Anne for wording on the sign (see printout of sign proposal). Ted made calls about pricing – simple metal sign to put on post – 12×18 by Signorama in Concord...one color - \$48; Two color – \$52

Kevin explained that Bob Rothschild is in control of the boat access since he owns the property – until someone challenges it (via court). If people complain – hire attorney - Bob did placed big rocks to keep trailers out of the Pond because of liability...if trailer pulled out and got hit...

Ted will get proofs of signage – Nancy McD has contact at Omni Signs in Meredith so she'll get quotes too.

Ted will contact Bob R about the sign's wording.

Mary Perry Conservation Committee – Rich/Kevin/Bob

Bob Maloney, Rich Cocchiaro and Kevin Frank were members of this active committee that prepared the reports sent out via email to Board members.

Kevin – funnel money through SLCS – Roger LaRochelle of SLCS is supportive - is aware that people spend money when conserving property...\$25k...formula based on how much is in the fund...funds raised by solicitation...anyone in area who wants to contribute...no details on fund drive yet.

Fund will increase through direct donation (tax deductible) or surplus from our general fund on an annual basis.

\$ distributed once a conservation project is completed - is that too restrictive? Front-ending of expenses

Reassurance? Formal agreement – once you complete project you will receive X dollars...approval in advance...person knows they will receive X dollars...

To raise money – solicitation should go to entire watershed...incl. SLA members.

Will asked if we should we send \$1250 today to SLCS. We agreed the check should be sent as soon as account is open and checks can be received. Ann Ireland so moved//Marty seconded and Board approved.

Process for managing the Fund: Designate person to manage fund – the treasurer. The Committee will reviews applications/approves and then sends to Board for approval – Board appropriates funds based on recommendation – Board could vote via email/phone.

Board approved the report from the Committee. Documents will be corrected by Kevin for distribution at annual meeting but the Annual Meeting announcement should tweak people's interest about the Fund.

Checks should be written to: SLCS – Mary H. Perry Conservation Fund and mail to Will or SLCS. SLCS would need to generate report to treasurer.

Hawk sighting

For publicity about our fund, Janet should ask SLA to include Mary H. Perry Fund in their newsletter – and SLCS' newsletter – generate press release after annual meeting.

Website Update/suggestions - Nancy Voorhis

Need to add new tab on Conservatio. The best process for a website is for people to go there – send Nancy suggestions – there's a feedback form on site...Other suggestions include a blog capability? Member login? Nancy suggested we go from com to org...i.e. Wopwa.org? The importance of changing to it to org rather than com is to imply an organization and not a business.

Member area login would be for Members only bulletin board...access to list, for rent, for sale, craft items for sale, event happenings, personal ad's, lost pet, men seeking men, bass seeking perch, etc. based on email addresses...

Link to SLA and SLCS are already there...applications online for viewing and printing...conservation groups need to be on the site...

Blog is description tied to individual...do we want a forum? "pond observations"...Nancy will start it..."I heard the loons last night"...so NOT a blog – it will be a forum...

Historical Documents/HHS - Anne knight/Kevin frank

Holderness Historical Society has file cabinet space available for storage of WOPWA documents...hard copy...do we want them scanned? (not all of them)...Galen will take them to HHS... Will's Treasurer's reports will be filed there and not scanned.
